Description of the award:

This award invites applications from all decision makers working within the NHS and local government who have helped to deliver results and steer change within their health economy. Entries are not limited to those chairing a CCG or leading on their local STP but are also open to those who have taken an innovative idea forward to their CCG to be commissioned or have implemented a practice-based service that has benefited the local community. Nominations may be based on an individual project which the nominee has undertaken or a collective impact over the last 18 months. We invite applications from both individuals themselves and nominations from colleagues.

Applications should demonstrate all or some of the below:

- A creative approach to developing innovative ideas, based on population needs.
- A locally focused service provision.
- Commitment to improving patient outcomes.
- Commitment to cost-effective delivery of services.
- Commitment to improving integration of services and working across organisational boundaries.
- The ability to demonstrate effective leadership and empower colleagues.
- Evidence of how their contribution is aligned with the objectives of the Five Year Forward View.

Criteria that judges will be marking against:

- Clear evidence of the impact of project(s) they have been involved with on their patients, surgery, or the local area.
- Evidence of exceptional local leadership, imagination and/or innovation.
- Clear and tangible outcomes of initiatives showing measured improvements in patient care, including clinical outcomes.
- Evidence of knowledge sharing between teams and organisations.
- Evidence of better working across multiple services within their local area.
