Description of the award:

This award seeks to recognise a Practice Nurse who has made an outstanding contribution in their local area/practice, to patient care or leadership. We invite applications from nurses themselves and also from practice colleagues.

Applications should demonstrate all or some of the below:

- A brilliant individual who has made a real difference to the provision of care in their practice in the last 18 months.
- Evidence that their individual efforts and imagination have improved patient care and/or safety; for example, through leading improvement projects, innovative teaching of nurse trainees, or patient education initiatives.
- Particular credit will be given to applications with evidence of good leadership and the overcoming of significant obstacles.
- Evidence of how their contribution is aligned with the objectives of the Five Year Forward View.

Criteria that judges will be marking against:

- Clear evidence of the nurse's impact on their patients, colleagues and practice.
- Evidence of exceptional dedication, imagination and/or innovation and how these qualities have influenced the outcome of their work.
- Measurable and defined improvements in patient care. This can include anecdotal or personal accounts.
- Evidence that the nominee exhibits key competencies and values of nursing which he/she continues to develop: such as the 6Cs (care, compassion, competence, communication, courage, commitment).
